- 1.11 "Trailer" means a vehicle which is not self-propelled and which is designed or adapted to be drawn by a motor vehicle but does not include a side-car attached to a motorcycle.

## 2. CLASSIFICATION OF MOTOR VEHICLES

### **Class 1:** *Light vehicles:*

Light vehicles are motor vehicles, other than heavy vehicles as defined above, with or without a trailer, and include motorcycles, motor tricycles and motor cars.

### **Class 2:** *Medium heavy vehicles:*

Medium heavy vehicles are heavy vehicles, as defined above, with two axles. v

### **Class 3:** *Large heavy vehicles:*

Large heavy vehicles are heavy vehicles, as defined above, with three or four axles.

### **Class 4:** *Extra large heavy vehicles:*

Extra large heavy vehicles are heavy vehicles, as defined above, with five or more axles.

### 3. TOLL TARIFF

- 3.1 The amounts of toll for the different categories of motor vehicles payable at the toll plazas located on the Platinum Toll Highway, for the usage of a section of toll road (or any part thereof), are stated in Table 1.

  - (e) a light delivery vehicle (a bakkie).

- 1.11 "Trailer" means a vehicle which is not self-propelled and which is designed or adapted to be drawn by a motor vehicle but does not include a side-car attached to a motorcycle.

## 2. CLASSIFICATION OF MOTOR VEHICLES

### **Class 1:** *Light vehicles:*

Light vehicles are motor vehicles, other than heavy vehicles as defined above, with or without a trailer, and include motorcycles, motor tricycles and motor cars.

### **Class 2:** *Medium heavy vehicles:*

Medium heavy vehicles are heavy vehicles, as defined above, with two axles.

### **Class 3:** *Large heavy vehicles:*

Large heavy vehicles are heavy vehicles, as defined above, with three or four axles.

### **Class 4:** *Extra large heavy vehicles:*

Extra large heavy vehicles are heavy vehicles, as defined above, with five or more axles.

## 3. TOLL TARIFF

## 3.1

The amounts of toll for the different categories of motor vehicles, payable at the toll plazas located on the Huguenot, Vaal River, Great North, Tsitsikamma, South Coast, North Coast, Mariannhill, Magalies and N17 Toll Roads, for the usage of the toll road, or any part thereof, are stated in Table 1.

**4. LOCAL USER TOLL TARIFF**

- 4.1 A local user toll tariff for different categories of motor vehicles, is granted, subject to the South African National Roads Agency Limited's (SANRAL) terms and conditions (available at the Toll Plazas), to registered *bona fide* residents, employers or employees, located within an approved local user area, on successful application to the appropriate toll operator.
- 4.2 The local user toll tariffs for the local user areas, as shown on the various maps attached to this Notice and of which a copy can be obtained from SANRAL, for the different categories of motor vehicles, payable at the Veerkeerdevelei, Grasmere, Capricorn and Baobab Toll Plazas located on the Vaal River and Great North Toll Roads are stated in Table 2.

**5. LOCAL PUBLIC TRANSPORT OPERATOR TOLL TARIFF**

- 5.1 A local public transport operator toll tariff, for Class 1 motor vehicles only, is granted, subject to SANRAL's terms and conditions (available at the Toll Plazas), to registered *bona fide* local public transport operators operating within an approved local user area, on successful application to the appropriate toll operator.

- 5.2 The local public transport operator toll tariffs for the local user areas, as shown on the various maps attached to this Notice and of which a copy can be obtained from SANRAL, for Class 1 motor vehicles only, payable at the Veerkeerdevelei, Capricorn and Baobab Toll Plazas located on the Vaal River and Great North Toll Roads, are stated in Table 4.

## 6. FREQUENT USER DISCOUNT

### 6.1

At specified toll plazas, a frequent user discount on the toll tariff, for Class 1 motor vehicles only, is granted to registered frequent users, who complete a prescribed number of passages within a stipulated period, on successful application to the appropriate toll operator. At some of the specified toll plazas, a registered *bona fide* local user and registered *bona fide* local public transport operator may also register as a frequent user. The frequent user discount, according to the number of passages completed within the stipulated period, is applied to the value of the total number of passages.

A Frequent User Card must be tendered for payment at a toll plaza – a Local User Card, Local Public Transport Operator Card, valid Credit Card (e.g. Visa or Master Card), or valid Fleet Management Card, may be registered as a Frequent User Card.

### 6.2

The frequent user discounts for the specified toll plazas located on the Huguenot, Vaal River, Great North, South Coast, North Coast, Mariannhill, Magalies and N17 Toll Roads, for Class 1 motor vehicles only, for the number of passages completed within the stipulated period, on the toll tariffs stated in the relevant tables, are stated in Table 5.

**7. DEBIT CARD DISCOUNT**

At the Tsitsikamma Toll Plazas on the Tsitsikamma Toll Road, a discount on the toll tariffs for the different categories of motor vehicles stated in Table 1 above, is granted when the number of passages, as stipulated in Table 6, are prepaid for, on a SANRAL Debit Card, irrespective of the period that the passages are completed. The debit card discounts for the stipulated number of passages prepaid for at the Tsitsikamma Toll Plazas, are stated in Table 6.

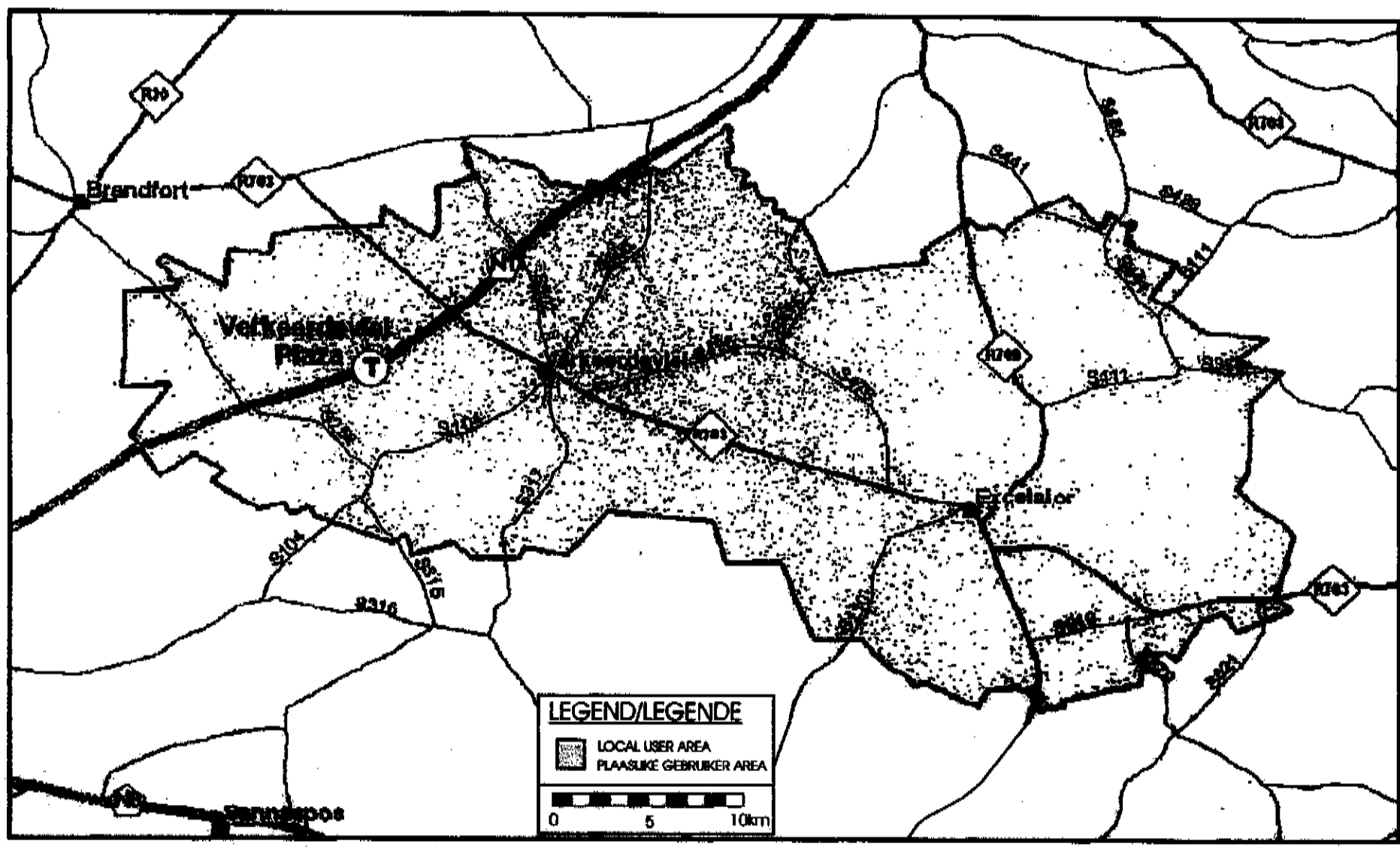

**8. OPERATIONAL HOURS**

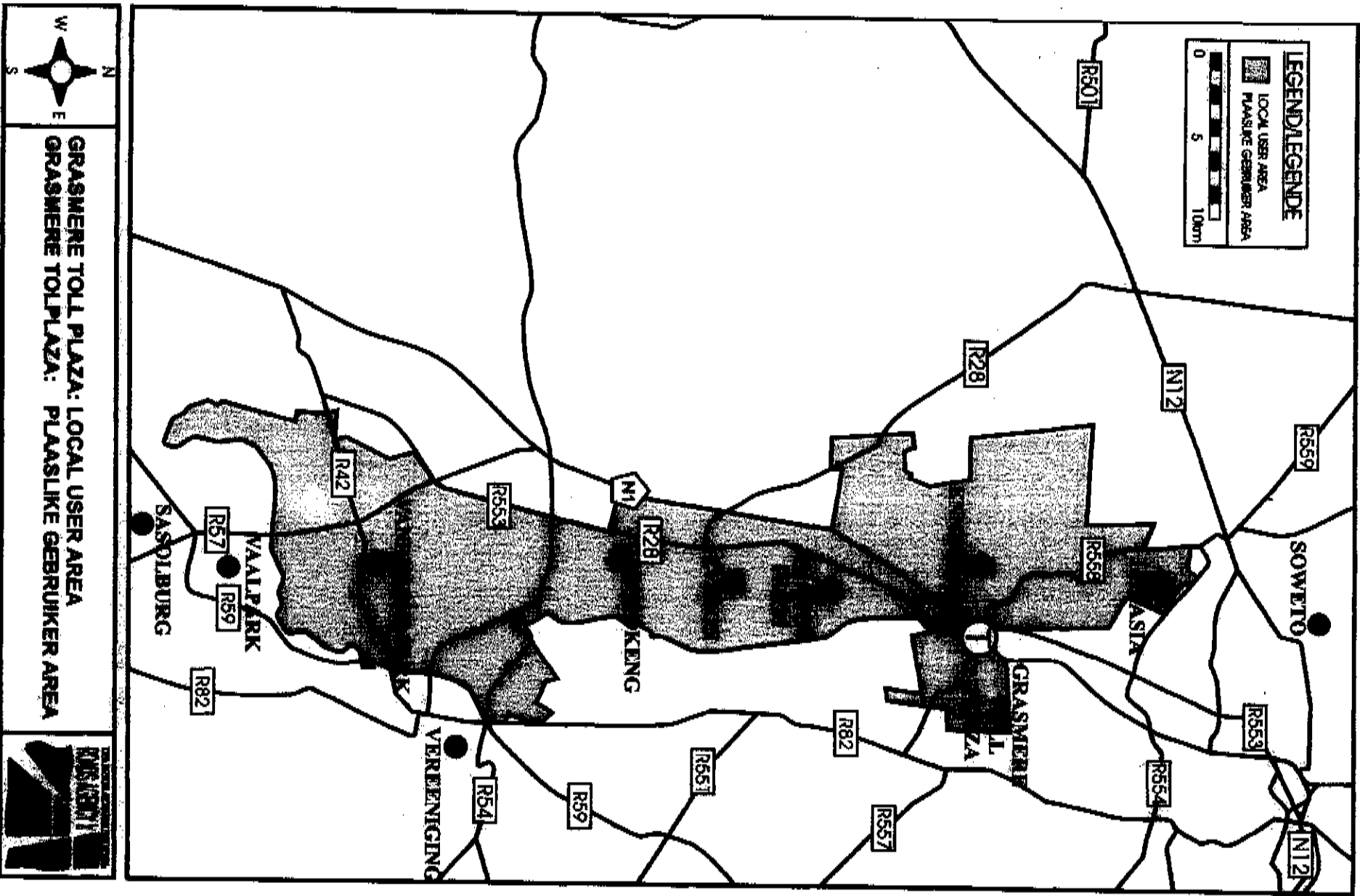
8.1 The said toll roads shall be open to traffic for 24 hours a day.

9.1 The date and time from which the said amounts of toll shall become payable, shall be 1 March 2009 at 00:00.

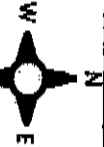

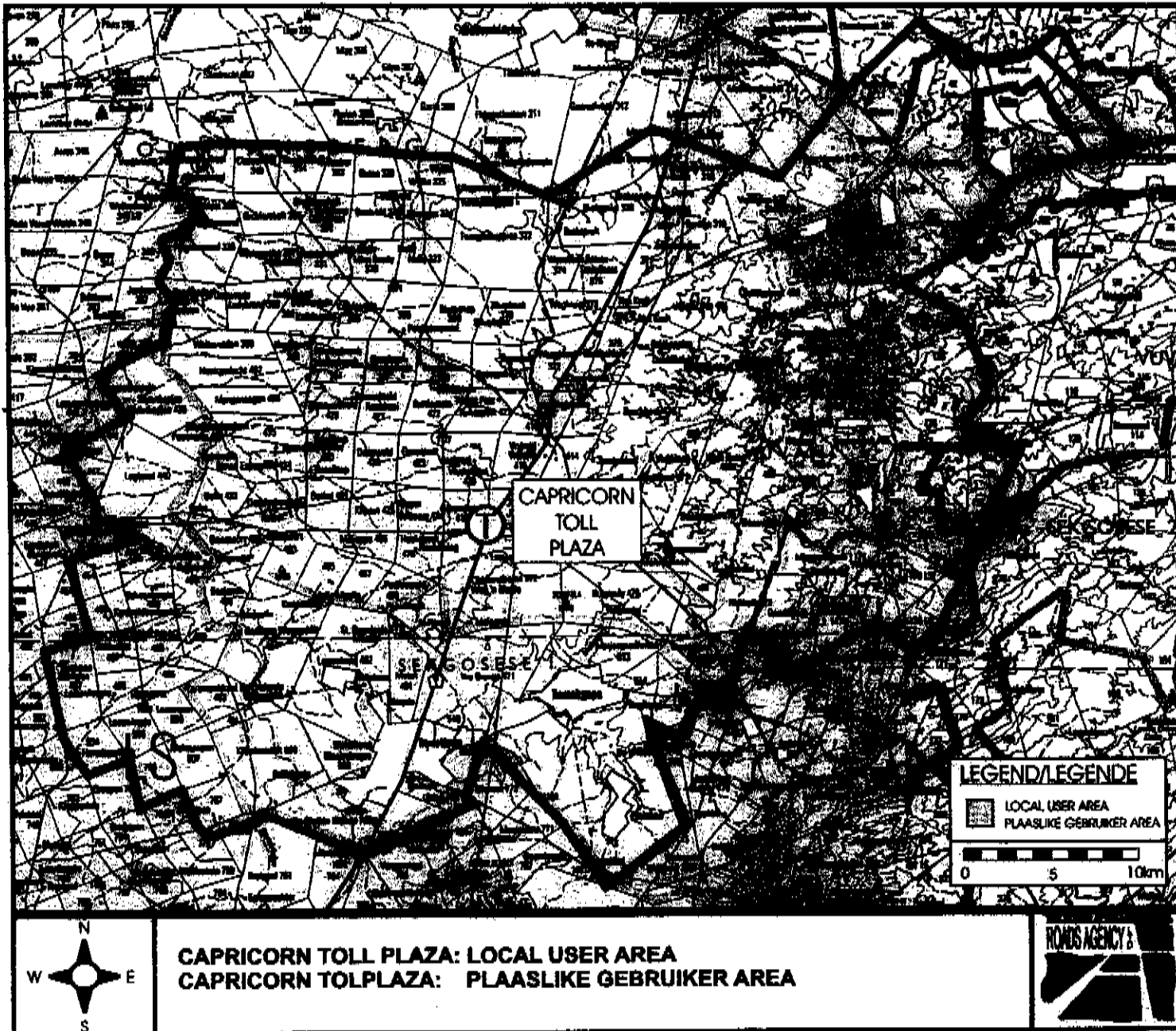

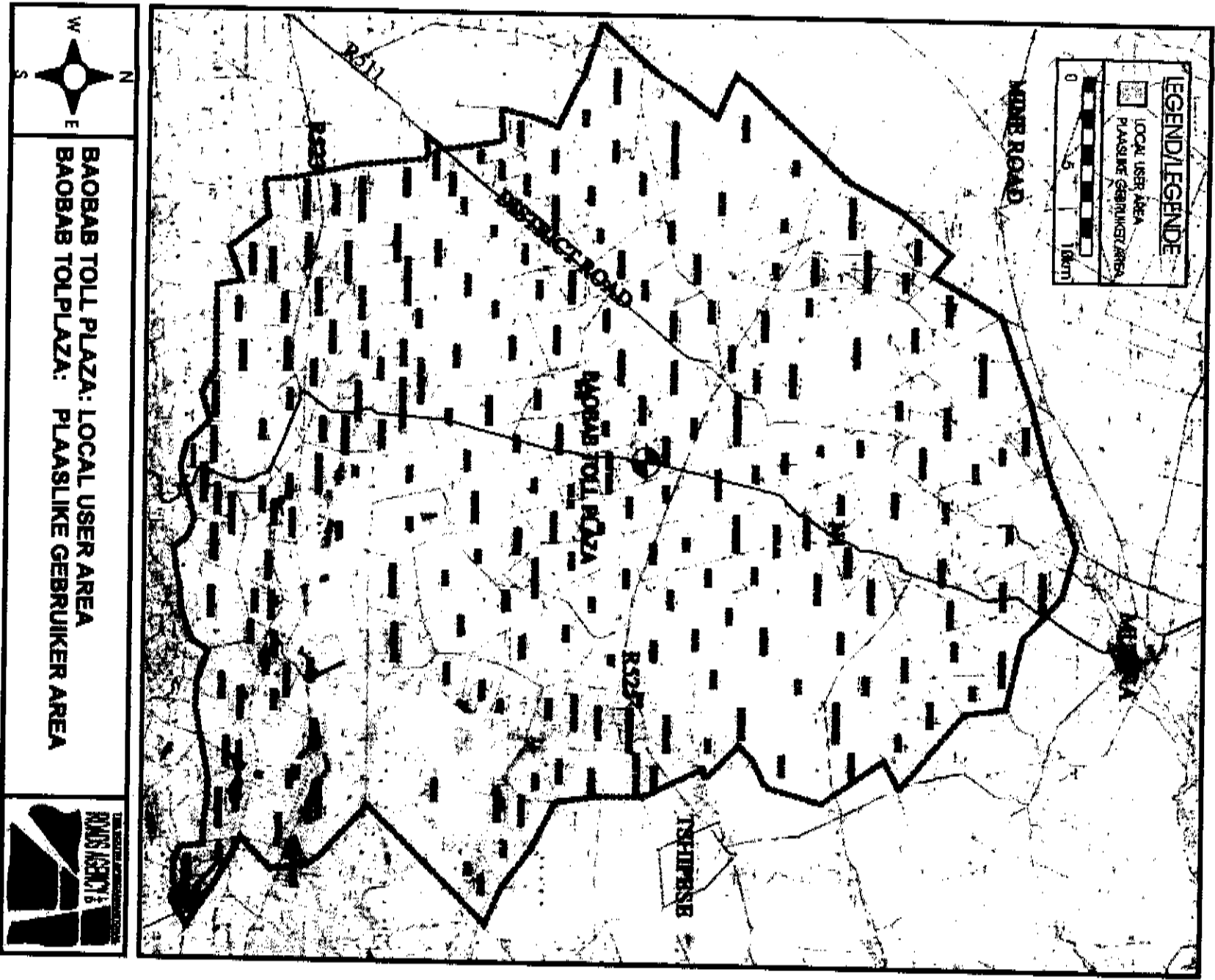
**GRASMERE TOLL PLAZA: LOCAL USER AREA**
