

**THE SOUTH AFRICAN NATIONAL ROADS AGENCY LIMITED AND NATIONAL
ROADS ACT, 1998 (ACT NO 7 OF 1998)**

**GAUTENG FREEWAY IMPROVEMENT PROJECT, TOLL ROADS: EXTENSION
OF GRACE PERIOD DISCOUNT FOR USERS MAKING PAYMENT AND
REGISTER**

The Head of Department of Transport hereby makes known, in terms of section 27(3)(c) of the South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), that the Minister of Transport has, in terms of section 27(3)(a) of the Act and on recommendation of the South African National Roads Agency SOC Ltd, that GFIP E-road Users who were charged the alternate toll tariff (as published in Government Gazette No. 37038 of 19 November 2013) for invoices during the period from 03 December 2013 to 28 February 2014 inclusive, be allowed to pay the standard tariff (as published in Government Gazette No. 37038 of 19 November 2013) provided they settle their outstanding account and register by 30 June 2014, effectively extending the discount grace period to 30 June 2014. This is an extension of the grace period discounts for transactions from 3 December 2013 to 28 February 2014 as defined in the tariff notice published by Notice R 887 in Government Gazette No. 37038, of 19 November 2013:

- The discount of 60% is applicable to the grace period as per clause 5.19.1 of that Tariff notice, and
- The qualification of the once-off registration discount of 6.67% as per clause 5.20.1 of that Tariff Notice



**GAUTENG DEURPAD VERBETERINGSPROJEK, TOLPAAIE: VERLENGING
VAN DIE AFSLAG GEDURENDE DIE GRASIETYDPERK VIR GEBRUIKERS WAT
BETAAL EN REGISTREER**

Die Hoof van die Departement van Vervoer maak hiermee ingevolge artikel 27 (3) (c) van die Wet op die Suid-Afrikaanse Nasionale Padagentskap Beperk en Nasionale Paaie, 1998 (Wet No. 7 van 1998), bekend dat die Minister van Vervoer, ingevolge artikel 27 (3) (a) van die Wet en op aanbeveling van die Suid-Afrikaanse Nasionale Padagentskap MBK (Bpk), bepaal dat GDVP E-pad gebruikers wat aangeslaan is ingevolge die alternatiewe toltarief (soos gepubliseer in Staatkoerant No. 37038 van 19 November 2013) vir fakture gedurende die tydperk vanaf 3 Desember 2013 tot 28 Februarie 2014 ingesluit, toegelaat word om die standaard tarief te betaal, (soos gepubliseer in die Staatkoerant No. 37038 van 19 November 2013) op voorwaarde dat hulle hul uitstaande rekening vir die periode vereffen en registreer voor of op 30 Junie 2014. Hierdie is 'n verlenging van die afslag gedurende die grasietydperk vir die transaksies vanaf 3 Desember 2013 tot 28 Februarie 2014, soos omskryf in die tariefkennisgewing gepubliseer deur Kennisgewing R 887 in Staatskoerant No. 37038, van 19 November 2013:

- Die afslag van 60% is van toepassing op die grasietydperk soos per klousule 5.19.1 van daardie tarief kennisgewing; en
- Die kwalifikasie van die eenmalige afslag met registrasie van 6.67% soos per klousule 5.20.1 van daardie tarief kennisgewing.
